**Waiver, Release of Liability and Indemnity Agreement**

You (Member and all guests an parents signing on behalf of any child under age 18) agree that if you, your guest or minor child engage in any physical exercise or activity or use any Gym facility on the premises, you do so at your own risk and assume the risk of any and all injury and/or damage while engaging in any physical exercise or activity or use of any Gym facility on the premises.

Your assumption of risk includes, without limitation, your use of any exercise equipment (mechanical or otherwise), restrooms, sidewalk, parking lot, stairs, lobby area, or any equipment in the Gym facility. Member agrees to assume the risk of his or her participation in any activity, class, program, meet, competition, instruction, or Gym-sponsored event. You agree that you are voluntarily participating in the aforementioned activites and using the Gym facilities and premises and assume all risk of injury, illness, damage, or loss to you or your property that might result, including, without limitation, any loss or theft of any personal property.

You agree on behalf of yourself, guest and minor child (and all personal representatives, heirs, executors, administrators, agents, and assigns) to release and discharge Gymnastics Nevada, its, officers, directors, shareholders, employees, owners, agents, and successors and assigns, from any and all claims or causes of action (know or unknown) arising out of the negligence of Gymnastics Nevada, whether active or passive, or any of its officers, directors, shareholders, employees, owners or agents.

This waiver and release of liability includes, without limitations, injuries which may occur as a result of (a) your use of any exercise equipment of facilities which nay malfunction or breaks. (b) the Gym’s improper maintenance of any exercise equipment or facilities, (c) the Gym’s negligent instruction or supervision, or any other form of negligence by the Gym or any employee of the Gym, and (d) slipping or tripping and falling while on the facility or any potion of the premises for any reason, including the gym’s negligent inspection or maintenance of the premises.

You also agree to waive any rights that you may have to commence an action or recover damages for any injury at the Gym premises to any minor child who is a guest or member. By execution of this agreement, you herby agree to indemnify and hold harmless the Gym from any loss, liability, damage, or cost that the Gym may incur due to your presence at the Gym facility.

You further agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the lase in the Start of Nevada and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
